do declare that I will agree to the following terms and conditions: (please initial after each section)

1. I am willing to allow inspection of the animal care area at my place of residence prior to and during the fostering of the above named animal(s). This inspection will be conducted by and at the discretion of a director or a volunteer designated by said rescue organization. _____

2. I understand that these animals shall be fostered temporarily at my place of residence, and that I will return these animals to said rescue group at their request. I agree to notify the rescue group in the event that I am no longer able to provide care for the animal(s) I am fostering. I will not give the animal(s) to another person or agency without the permission of the rescue group. I will also notify the rescue group if the animal(s) I am fostering are lost or stolen. _____

3. I agree to provide the animal(s) I am fostering with good and loving care, including adequate food and water, shelter from the elements, daily exercise, and medication or veterinary care as needed. _____

4. If I am fostering a cat, I agree to keep the cat strictly indoors, going outside only on a harness or into a secure cattery. _____. If I am fostering a dog, I agree to keep the dog under my control at all times, going outside only on a leash or into a securely fenced area. _____

5. I agree to keep an identification tag attached to a properly attached collar that will remain on the foster animal(s) at all times. _____

6. I understand that all expenses associated with the animal(s) I am fostering must be approved in advance. All basic medical and general expenses will be covered by said rescue group if the foster home is unable to pay them. We appreciate any willingness to donate basics (food, toys, collar, leash, etc.) _____

7. I understand that said rescue group maintains superior title to the animal(s) that I am fostering and I agree to return the animal to that group upon demand. I further agree that if it is determined at any time that any of the terms of this agreement have not been fully complied with, I will return the animal upon demand. _____

8. I understand that, should I decide I would like to adopt the animal(s) I am fostering, I will be required to contact the rescue group and complete the adoption application procedure. I understand that fostering the animal does not guarantee approval for adoption. _____

9. I understand that the said rescue group cannot guarantee the health, temperament, or training of the animal(s) I am fostering. I, hereby for myself, heirs, administrators and assigns, fully, irrevocably, and unconditionally release and agree to hold harmless the *Hanna S.P.C.A* and its individual members from any and all known or unknown, anticipated or unanticipated, suspected or unsuspected and/or fixed, conditional, or contingent, actions, causes of action, charges, suits, debts, demands, claims, contracts, covenants, liens, rights, liabilities, losses, royalties, costs, expenses (including, without limitation, attorney's fees) or damages, including but not limited to any medical costs, damages to property, persons or other pets, of every kind, nature and description, at law or in equity, in connection with or arising from while I am caring for the agreed rescue animal. _____

10. I have received a copy of the foster home handbook and have reviewed the contents with a Hanna S.P.C.A. foster home Coordinator. _____
